Request for Proposal Bridge Park Stage Design and Construction Due by April 30, 2021 @ 4 PM

The Rockdale Municipal Development District (RMDD), located in Rockdale, Texas, is requesting proposals for design and construction of a 10 foot wide by 20 foot long covered stage for performances. The stage will be located in the southeast quadrant of the park, 150 feet southeast of and centered between the bridges.

Proposals will be accepted until Friday, April 30, 2021 at 4:00 PM.

All proposals must be in a sealed envelope and either mailed or hand delivered to PO Box 586, 505 W. Cameron Avenue, Rockdale, Texas 76567 and marked:

Proposals may be sent by mail, courier or hand delivered. Faxed or emailed documents will not be accepted. Late submissions will not be accepted. The RMDD assumes no responsibility for proposals not processed due to the failure of the Bidder to identify the envelope as a bid response.

All pricing information required of the bidder, unless otherwise specified, must be completed and submitted with this REQUEST FOR PROPOSAL. Persons signing the proposal must be an officer or person authorized to sign the proposal.

The RMDD reserves the right to reject any or all proposals or to waive any informality in the proposals, or to omit and/or alter any proposal item if it appears to be in the RMDD's best interest.

The RMDD reserves the right to request additional data or information or a presentation in support of written proposals.

The RMDD is tax exempt under Tax Code, Subtitle E. SALES, EXCISE AND USE TAXES, CHAPTER 151, Section 151.309. Bidder, if awarded the bid, shall be responsible for and shall pay all sales, excise, use and other taxes. When equipment, materials or supplies generally taxable to the bidder are eligible for a tax exemption due to the nature of the item, bidder shall assist the RMDD in applying for and obtaining such tax credits and exemptions which shall be paid for credited to the RMDD.

Proposal amounts shall remain in effect ninety (90) days after opening.
