Call to order and announcement of a Quorum

With a quorum present, the Rockdale Municipal Development District Board Meeting was called to order by Board President Adam Straznicky at 6:00 p.m. on Tuesday, January 3, 2017 at Rockdale Municipal Development District Offices, 134 N. Main, Rockdale, Texas.

5. Action Items

Upon brief discussion of each listed topic no action was taken.

- B. Discussion and possible action: evaluation of Board Member Allan Miller in light of discussion under previous agenda item. (Tex. Gov't Code Sec. 551.074)

Motion: A motion was made by Board Member Straznicky to place Board Member Allan Miller on conduct restriction until July 3, 2017 to include limiting his correspondence with personnel.

The Motion Failed for lack of a second.

After lengthy discussion, it was the consensus of the MDD Board of Directors that concerns of Board Members should be addressed by the entire Board in an open meeting and not directly with personnel.

Board Member Miller stated he would not agree to that.


